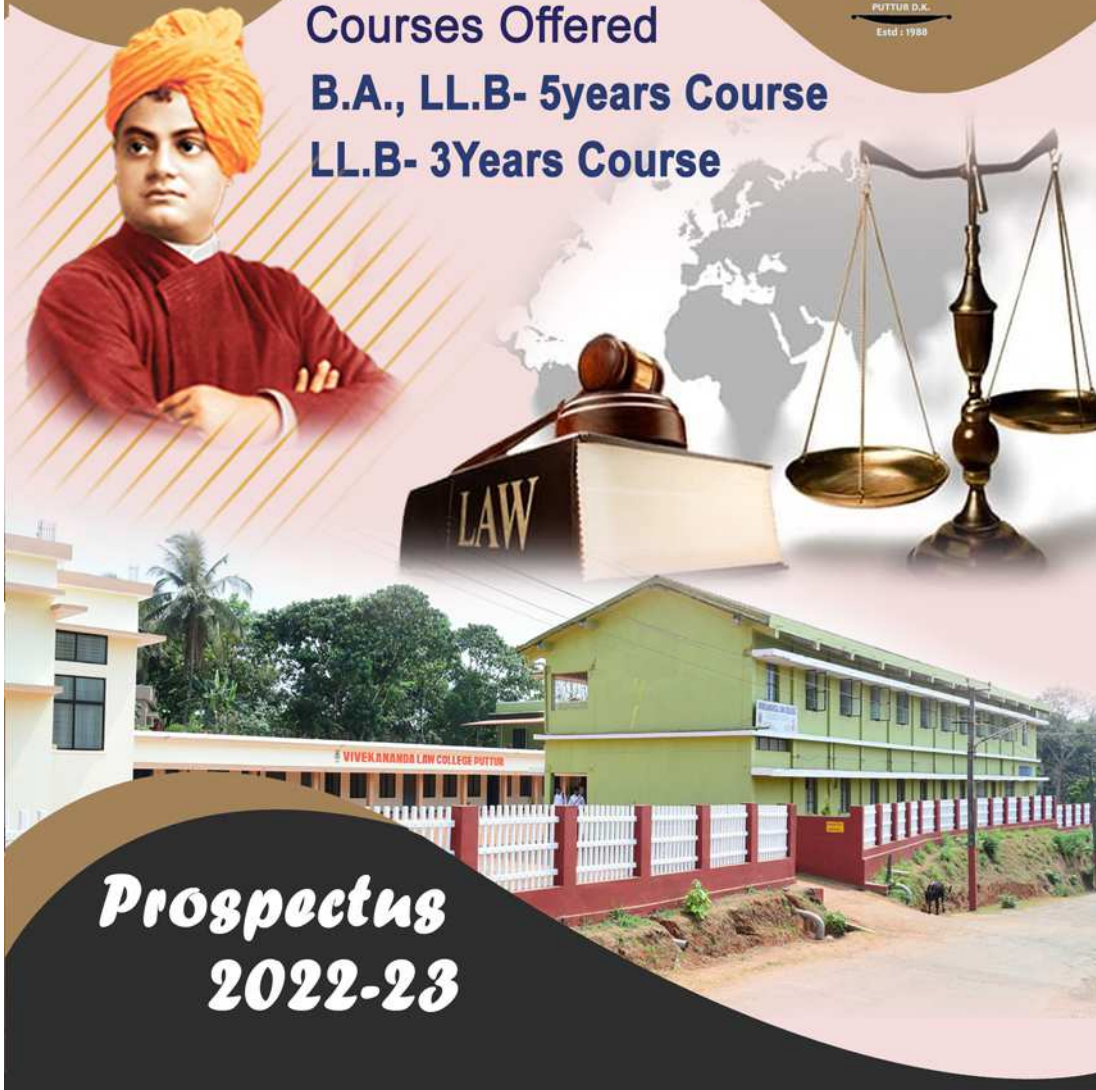

## **AIMS OF THE COLLEGE**

This Law College was founded at Puttur during the year 1988-89 in order to meet the growing need of the students seeking legal education in south eastern areas of Dakshina Kannada District, Kodagu and other adjoining Districts of Karnataka and the Kannada speaking Kasaragod area of Kerala State. It is also intended to make legal education available nearer home so that even the less fortunate sections of the people in the region might profit from this professional course of study.

The founders believe that no education, professional or otherwise will be worth the name if the imparting of instruction in different branches of knowledge is not attended by a proper shaping of character. The college has its name 'Vivekananda' from whose life and work it derives its name, inspiration and aims at high sense of discipline and character. The College has adopted 'Nyayen Dharyathe Lokah' in its motto which means 'The structure of the world is kept in balance by justice'.

## **TIMINGS**

The classes will be conducted from 9.00 am to 12.10 pm and from 1.00 pm to 4.10 pm. The Library is open from 9.00 am to 5.00 pm

## **SCHOLARSHIPS**

Scholarships will be available to the students as per government rules in force. The award of scholarship is subject to satisfactory progress, attendance, good conduct and character. Endowment prizes will be awarded to meritorious students.

## **MISCELLANEOUS**

Admissions made are subject to the approval by the University. Students admitted to the college will have to maintain strict discipline and follow the rules and regulations formulated by the College authorities from time to time. Students have to wear uniform prescribed by the college. Use of mobile phones in the college campus is prohibited. Locker facility is available to keep mobile phones.

## **DRESS CODE**

1. Students entering the college campus shall be in uniform, including on examination days & holidays.
2. During internship, visiting the chambers and courts students shall be in uniform.
3. Formals only allowed. Jeans, Cotton jeans etc. are not permitted.
4. Tight, pencil cut pants and tight shirts, low waist pants, waist level shirts not allowed.
5. Pants shall be full length only.
6. Sleeveless, sleeve cut, body tight dresses are not allowed.
7. Top's length shall NOT be above knee point.
8. Boys shall come with formal haircut and properly shaved.

9. Girls shall stitch the badge to the upper portion of the left sleeve. Boys shall stitch the badge on the pocket.
10. The students who fail to observe the dress code will not be allowed to the classes.
11. Use of scarf or head covering is not allowed.
12. Type of dress :  
Boys: White full sleeve shirt and black pant  
Girls: Chudidhar - White three fourth sleeve, collar top, black patiyala bottom and black veil.

### **REGULATIONS GOVERNING THE 5 YEARS BA, LLB DEGREE COURSE**

1. **THE COURSE & DURATION:** BA, LLB integrated double degree course combines Bachelors' degree course in Arts together with the Bachelors' degree course in law. The duration of the course shall be five academic years consisting of ten semesters.
2. **ELIGIBILITY FOR ADMISSION:** An applicant who has successfully completed Pre-University Course or Senior Secondary School Course (+2) or equivalent course is eligible for admission to the course. Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of general category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC & ST applicants. Applicants who have passed qualifying examination through Open University system directly without having any basic qualification for prosecuting such studies are not eligible for admission to the course.
3. **MEDIUM OF INSTRUCTION:** The medium of instruction is English. However, the examinees shall have the option to answer the question papers in the examination either in English or in Kannada.
4. **ATTENDANCE:** No student shall be permitted to appear for the end-of-semester examination in a given course unless he/she has, to the

satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 75% attendance in the course concerned.

5. **PROMOTION:** A total carryover will be given. Students are required to successfully complete the entire course within seven years from the year of admission to the course. The students shall have paid the examination fees to the University for both semesters of the academic year.

6. **MAXIMUM AGE LIMIT:** 20 years in case of General Category and 22 years in the case of SC, ST and Other Backward communities categories.

7. **AWARD OF THE DEGREE:** A student shall be eligible for the award of BA,LLB degree after he/she has successfully completed all the prescribed courses in all the semesters and has secured a minimum of 40% in theory and in aggregate provided his or her character and conduct are found satisfactory during the course.

## **REGULATIONS GOVERNING THE 3 YEARS LLB DEGREE COURSE**

1. **THE COURSE & DURATION:** LL.B. 3 year degree course shall be of 3 years' duration spread over 6 semesters.
2. **ELIGIBILITY FOR ADMISSION:** An applicant who has graduated in any discipline of knowledge from a University is eligible for admission to the course. Minimum percentage of marks (aggregate) in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of general category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC & ST applicants. Applicants who have passed qualifying examination through Open University system directly without having any basic qualification for prosecuting such studies are not eligible for admission to the course.
3. **MEDIUM OF INSTRUCTION:** The medium of instruction is English. However, the examinees shall have the option to answer the question papers in the examination either in English or in Kannada.
4. **ATTENDANCE:** No student shall be permitted to appear for the end-of-semester examination in a given course unless he/she has, to the satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 75% attendance in the course concerned.
5. **PROMOTION :** A total carryover will be given. Students are required to successfully complete the entire course within five years from the

year of admission to the course. The students shall have paid the examination fees to the University for both semesters of the academic year.

6. **MAXIMUM AGE LIMIT:** 30 years in case of General Category and 35 years in the case of SC, ST and Other Backward communities categories.

7. **AWARD OF THE DEGREE:** A student shall be eligible for the award of LL.B. degree after he/she has successfully completed all the prescribed courses in all the semesters and has secured a minimum of 40% in theory and in aggregate provided his or her character and conduct are found satisfactory during the course.
