DISCIPLINARY RULES

- 1. The students are required to maintain the highest standard of behaviour and discipline both inside and outside the College
- 2. The student shall strictly observe the disciplinary rules framed by the college or which may be framed from time to time
- 3. The student must attend the classes regularly.
- 4. The student must attend the college functions and meetings.
- 5. The students should assemble in the class-room on ringing the bell and wait silently for the Lecturer and allow Lecturer to conduct the class smothly. No student should wait on the veranda for the Lecturer to come.
- 6. No student shall enter the class without permission of the Lecturer.
- 7. Students who have no class shall not loiter in the veranda or other premises of the college and also shall no cause disturbance for the conducting of other classes.
- 8. The student must not cause any damage to the College property or to any property within the College premises
- 9. Without the permission of the Principal, the students shall not organise any activity or associate with any other group not connected with the college.
- 10. Smoking within the College premises is strictly prohibited.
- 11. No student must enter the College premises by taking alcohol not he must consume alcohol within the premises of the college.
- 12. Participation in political agitation or demonstration or participation in strikes of any kind is strictly prohibited
- 13. The students must keep the class rooms and the College premises clean and writing on the black board, walls etc; are strictly prohibited. Affixing the posters is also strictly prohibited.
- 14. Irregular attendance, indifference, discourtesy towards Letcturers, insubordination, obscenity in words or act failure to follow the disciplinary rules is liable for disciplinary action which include expulsion from the college.
- 15. Student who is found to have committed any act of indiscipline is liable to any one or more of the following punishments.
 - i) Warning
 - ii) Censure
 - iii) Fine
 - iv) Cancellation of Scholarship / Freeships etc.
 - v) Recovery in part or full of loss or damages to the college property or property of others caused by the delinquent students.
 - vi) Removal, rustication or expulsion from the college.
 - vii) Witholding of certificates.

The punishments are liable to be inficted summarily at the discretion of the Principal whose decision will be final.
